- \_\_\_\_\_ Initial Yearly membership starts April 1<sup>st</sup> and ends March 31<sup>st</sup>
- \_\_\_\_\_ Initial Memberships are prorated in October, no earlier
- \_\_\_\_\_ Initial Memberships do NOT give you access to the Living Water Pool or amenities
- \_\_\_\_\_ Initial Members must provide a valid Membership when checking into the Recreation front desk before the use of Recreation Centre facilities
- \_\_\_\_\_ Initial Appropriate language towards staff, management and public must be used at all times. If this is not adhered to, Management may ask members to leave the facilities or members may have their memberships canceled without refund
- \_\_\_\_\_ Initial Family memberships are for the immediate family with children under the age of 18 living in the household and single memberships are for one individual
- \_\_\_\_\_ Initial Memberships cannot be transferred or sold to a third party
- \_\_\_\_\_ Initial Members cannot bring guests for free. A Recreation Centre 1 day, 7 day and 10 day pass can be use of the Recreation Centre and Family outdoor pool only
